

INFORMATION CLAUSE

based on art. 13 § 1 and § 2 of the general regulation on the personal data protection of April 27, 2016. (hereinafter: GDPR)

PERSONAL DATA ADMINISTRATOR:

Klub Żak - a municipal cultural institution with headquarters in Gdańsk at ul. Grunwaldzka 195/197, 80-226 Gdańsk, NIP 5830004739, REGON 190510481, Register of Cultural Institutions run by the Municipality of the City of Gdańsk, entry: 5/98 (hereinafter the Klub Żak).

INFORMATION ON THE PROCESSING OF PERSONAL DATA:

1. In matters related to the processing of your personal data (as a person whose personal data is being processed), please contact the Personal Data Administrator using the e-mail address: biuro@klubzak.com.pl, or iod@klubzak.com.pl, or by post to the address of Klub Żak.
2. Your personal data will be processed in order to accept your application for the Competition / project, to conduct enrollment for the Competition / project and publish its results on the website www.gdanskifestiwaltanca.pl and to sign a contract with you in the event that you are qualified to participate in the Competition / project pursuant to Art. 6 (1) (a) and (b) of the GDPR.
3. Your personal data will be kept for the period of the selection process for the Competition / project and publication of its results on the website www.gdanskifestiwaltanca.pl, and in the event that you are qualified for the Competition / project for the duration of the realization of the Project, contracted between You and the Organizer (Klub Żak), then until the expiry of the limitation period for claims arising from it.
4. The personal data provided by you will not be transferred to a third country (outside the European Economic Area), but may be made available to other recipients authorized to account and control the activities of the Klub Żak, in accordance with applicable law, entities, co-financing cultural and educational projects implemented by Klub Żak, entities providing legal services for Klub Żak, hosting company providing email services to Klub Żak, telecommunication operators providing ICT services for Klub Żak.
5. You have the right to access your personal data, rectify it, delete it or limit processing, as well as the right to transfer data.
6. You also have the right to object to further processing, and in the event of having given consent to the processing of data, to withdraw your consent. The exercise of the right to withdraw consent does not affect the processing that took place until the consent was withdrawn.
7. You have the right to lodge a complaint with the President of the Personal Data Protection Office if you feel that the processing of your personal data violates the provisions of the GDPR.
8. Providing your personal data is voluntary, but if you do not provide your personal data will disable Klub Żak to accept your application for the competition.
9. Your data will not be processed in an automated manner, including the form of profiling.
